REGISTRATION:

The person named on the Application/Contract is the person considered by the World Massage Festival as the official contact of the participating entity for all purposes related to the program.

World Massage Festival shall have sole control over all admissions policies. Person(s) working in a booth must be registered and wear an official identification badge while in attendance.

The official contact person will receive a confirmation letter upon receipt of payment and signed contracts. Prior to the convention you will also receive your booth assignment(s). Your representative(s) will need to sign in at the World Massage Festival registration desk (where they will receive their name badges and complete Convention scheduling information).

BOOTHS:
