Exhibitor Information & Memorandum of Understanding

REGISTRATION:

The person named on the Application/Contract is the person considered by the World Massage Festival as the official contact of the participating entity for all purposes related to the program.

The official contact person is responsible for providing on-site representative(s) with time schedules and other pertinent information. **A maximum of two (2) representatives per booth is allowed.**

World Massage Festival shall have sole control over all admissions policies. Person(s) working in a booth must be registered and wear an official identification badge while in attendance.

The official contact person will receive a confirmation letter upon receipt of payment and signed contracts. Prior to the convention you will also receive your booth assignment(s). Your representative(s) will need to sign in at the World Massage Festival registration desk (where they will receive their name badges and complete Festival scheduling information).

For room reservations, please call the T-Bar-M Resort & Conference Center at 1-800-292-5469. Room rates vary, be sure to mention **WORLD MASSAGE FESTIVAL** to get the World Massage Festival block room rate. **ROOM RESERVATIONS MUST BE MADE BY MARCH 15, 2009.**

EXHIBIT HOURS:

Vendor check-in and set-up is Friday, April 24, 2009 from 12:00 noon to 4:00 pm. Vendor hours are Friday, 4:00 pm to 6:00 pm (or can stay open during Vendor party), Saturday, April 25, 2009, 8:00 am – 7:00 pm and Sunday, April 25, 2009, 8:00 am – 2:00 pm. Booths/exhibits may not be taken down nor materials removed until after 2:00 PM on Sunday.

BOOTHS:

All booths are approximately 10 ft. x 20 ft. Two tables & 2 chairs will be provided. Tables will be covered but not skirted. No pipe and drape. **Signs or other features may NOT be attached to the walls behind the booths and may not obstruct or interfere with walkways.**

EXHIBITS & PUBLIC POLICY:

Each exhibitor is charged with knowledge of all laws, ordinances and regulations pertaining to health, fire prevention and public safety, while participating in the World Massage Festival. Should an exhibitor have any questions as to the application of such laws, ordinances, and regulations, the World Massage Festival will endeavor to answer them or to direct the exhibitor to the best source of information.

ELIGIBILITY FOR EXHIBITING:

All products and services must be germane to the practice of Massage Therapy or be approved in advance by the World Massage Festival. Content of the exhibits is subject to approval. The World Massage Festival reserves the

right to refuse entrance/set-up to companies not meeting standards required or expected, as well as the right to curtail or to close exhibits or parts of exhibits that reflect unfavorably on the character of the World Massage Festival. This includes, but is not limited to exhibits which are deemed unsuitable because of noise, flashing lights, method of operation or display of unsuitable material as determined by the management of the World Massage Festival. This applies to displays, literature, advertising, novelties, souvenirs, conduct of persons, etc. Exhibitors may not assign, sublet or share any portion of their space. Exhibitors may not enter another exhibitor's booth/space without permission.

SALES TAXES:

In accordance with Texas's Tax Statute, exhibitors must collect a 8.25% sales tax on sales of tangible personal property. Consult your attorney or the Texas Department of Revenue to determine tax exemptions if no sales are made within the state. All exhibitor names and addresses will be submitted to the Texas Department of Revenue.

ASSIGNMENTS:

World Massage Festival reserves the right to relocate or reassign exhibit booths at any time for the benefit of the program.

LIABILITY:

All property of the exhibitor remains under his/her control in transit to and from the Conference Center and while it is in the confines of the Conference Center. Neither the World Massage, their service contractors, the management of the T-Bar-M Resort & Conference Center nor any officers, staff members or directors of any of the same are responsible for the safety of the property of exhibitors from theft, damage by fire, accident, vandalism, or other causes, and the exhibitor expressly waives and releases any claim or demand he may have against any of them by reason of any damage to or loss of any property of the exhibitor. The World Massage Festival will exercise reasonable care for the protection of exhibitor's materials and displays. The World Massage Festival, staff & volunteers will not be liable for the safety of the exhibitor's property.

RESPONSIBILITY CLAUSE:

Exhibitor assumes responsibility and agrees to indemnify and defend the World Massage Festival and the T-Bar-M Resort & Conference Center and its respective owners, employees and agents against any claims and expenses arising out of the use of the Conference Center. In the event of the World Massage Festival is canceled due to fire, strikes, government regulations, acts of God, or any causes beyond the control of the World Massage Festival, the World Massage Festival shall not be held liable for failure to hold the Festival as scheduled. The World Massage Festival will not be held liable for any expenses incurred and will determine the amount of refunds.
